

# Marine Sanitation Device Discharge Regulations



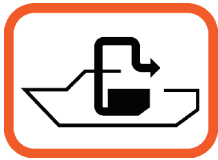
**Effective:** December 27, 2010

## Activities prohibited Sanctuary-Wide:

- Discharge of sewage incidental to vessel use and generated by a marine sanitation device in accordance with the Federal Water Pollution Control Act (also called the *Clean Water Act*).
- Having a marine sanitation device that is not secured in a manner that prevents discharges or deposits of treated and untreated sewage. Acceptable methods include, but are not limited to, all methods that have been approved by the U.S. Coast Guard.
