Note:

>> All applications created but not submitted will VOID in the system after 60 days for system maintenance.

>> Extension requests for non issued permits for 90 days can be made to Building Official

>> Extension requests for issued permits for 180 days can be made to Building Official using form found on MC Building PERMITTING FEES, FORMS & APPLICATIONS webpage

(1) = Issued Permits that Do Not Expire: 180 days to be issued, no expiration after issuance

(2) = Standard Permit Expiration: 180 days to be issued, 6 months (184 days) after issuance and then 180 days after each Passed inspection.
