The Department of Economic Opportunity (“Department”) has completed its review of the comprehensive plan amendment for Monroe County adopted by Ordinance No. 039-2019 on October 16, 2019 (Amendment No. 19-05ACSC), which was received and determined complete on November 25, 2019. We have reviewed the amendment in accordance with the state coordinated review process set forth in Sections 163.3184(2) and (4), Florida Statutes (F.S.), and have determined that the adopted amendment meets the requirements of Chapter 163, Part II, F.S., for compliance, as defined in Section 163.3184(1)(b), F.S. The Department is therefore issuing a Notice of Intent to find the comprehensive plan amendment “In Compliance.” A copy of the Notice of Intent is enclosed and will be posted on the Department’s Internet website. 


